Membership in TVAA entitles the artist to several opportunities to exhibit each year, educational programs, workshops and social activities.



## ENTRIES

All entries must be presented as digital files. CD should be clearly marked with Artist name, e-mail address and phone number Enclosed files should be labeled: your last name; Smith01, Smith02, Smith03. . ENTRIES: JPG high quality, full color & accurate scale. No photographic or digital enhancement except to insure accuracy of image No framing or presentation in image. Between 1000 and 1500 pixels in major dimension. Resolution - 300. Not larger than 1MB per image. Your entry form should be mailed at the same time with entry fee. **Membership should be current and/or paid before the entry form is mailed.**

## FEES - ELIGIBILITY

Open to all members of TVAA. Entry fee \$35.00 for 3 entries. All entries must have been completed **within the past 2 years**. Works cannot have been shown in **any** TVAA juried competitions.

## SALES

TVAA request a 20% donation for our scholarship fund.

## 2D WORK

Framed or finished canvas edges, wired for hanging (no saw tooth hangers). Fragile work under Plexiglass only, except for pastel. Size **MUST NOT** exceed 48" x 48" horizontally or vertically.

## 3D WORK

3 D work may be submitted by three images. *Sculptors will have to provide their own pedestal or display stand and attach their work in a secure manner.*

## LIABILITY

TVAA and Pfamily Arts will not be responsible for the loss of or damage to any work of art. Entry into this exhibition constitutes the artist's agreement to these terms and conditions. TVAA and the Pfamily Arts reserve the right to not show any works not deemed appropriate for public viewing.
