Michael says, "I think of my work as impressionistic. I like to represent people or places and allow the painting to evolve from the structure of what is recognizable. The challenge is to balance the care needed to make the representation interesting... and perhaps believable, with the freedom, looseness and painterly quality that makes painting so unique and expressive."

Jurying guidelines to consider:

Several factors contribute to making great art: Principles and elements of design evident to the viewer and are they handled well? What does the overall composition of the piece do to convey the meaning? Is there a story being told and is the story accessible to the viewer---what is the artist trying to say? Does the artist have a grasp of the medium and utilize it effectively?

- * Plex only, except for pastel.

- * Juror and PFAMily Arts will have authority to exclude any piece for any reason either during the jury process or judging process.

ENTRIES

All entries must be presented as digital files. CD should be clearly marked with Artist name, e-mail address and phone number Enclosed files should be labeled; your last name; Smith01, Smith02, Smith03. .

JPG: JPG high quality, full color & accurate scale.

No photographic or digital enhancement except to insure accuracy of image *No framing or mats shown* in image. Between 1200 and 1500 pixels in largest dimension. Resolution - 300. Not larger than 1MB per image. Your entry form should be mailed at the same time with entry fee. *Membership should be current and/or paid before the entry form is mailed.* e-mail your images to: gabypruitt@me.com

FEES - ELIGIBILITY

Open to all members of TVAA. Entry fee \$35.00 for 3 entries. All entries must have been completed *within the past 2 years*. Works cannot have been shown in *any* TVAA juried competitions. (you must be a member to participate in this juried competition).

SALES

2D WORK

Framed or finished canvas edges, wired for hanging (no saw tooth hangers).
Fragile work under Plexiglass only, except for pastel. Size MUST NOT exceed 48" x 48" horizontally or vertically.

3D WORK

3 D work may be submitted by three images.
Ceramics & Sculpture will have to provide their own pedestal or display stand and attach their work in a secure manner.

LIABILITY

TVAA and PFAMily Arts will not be responsible for the loss of or damage to any work of art. Entry into this exhibition constitutes the artist's agreement to these terms and conditions. TVAA and the PFAMily Arts reserve the right to not show any works not deemed appropriate for public viewing.
