Matt Anzak



Matt Anzak, the Art Director at LuminArte Gallery, works closely with artists from around the USA and from more than two dozen countries, showcasing the artwork of international artists alongside regional and local talent. Matt began his international art career in 1992 while studying Russian Art and Architecture, which allowed him unprecedented access to travel and study within post-Soviet era Russia, followed by an education in fine art at the University of North Texas. Matt Anzak has shown his multimedia artwork throughout the United States, including New York, San Francisco, Santa Fe, Miami and Dallas, as well as in international art epicenters such as London, Paris, Florence, Prague and Sydney. Matt has worked with cultural organizations including the Islamic Art Revival Series in DFW, ProArt and Contraria Arte in Ferrara, Italy, and Bhavan Australia in Sydney, and is a founding member of Ivy Paris in Paris, France. Matt has organized exhibitions at LMNT Gallery in Miami, Florida and at Galleria Daliko in Krems, Austria; and he has been active as the Group Coordinator for the International Biennale Artists group as well as working with Artura in Tel Aviv and with the Iraqi Ministry of Culture and the Iraqi Cultural Center in Washington, DC.

MEMBERSHIP

Membership in TVAA entitles the artist to several opportunities to exhibit each year,

ENTRIES

All entries must be presented as digital files. CD should be clearly marked with Artist name, e-mail address and phone number. Files should be labeled; your last name; Smith01, Smith02, Smith03. .
ENTRIES: JPG high quality, full color & accurate scale. No photographic or digital enhancement except to insure accuracy of image *No framing or mats shown* in image. Digital files are to be 1280 pixels (longest dimension) 300 dpi resolution.
Not larger than 1MB per image.

FEES – ELIGIBILITY

Open to all members of TVAA. Entry fee \$35.00 for 3 entries. All entries must have been completed *within the last 2 years*. Works cannot have been shown in *any* TVAA juried competitions. (you must be a member to participate in this juried competition.)

SALES

TVAA requests a 20% donation when a sale is made.

2D WORK

Framed or finished canvas edges, wired for hanging (no saw tooth hangers), Fragile work under Plexiglas only, except for pastel. Size **MUST NOT** exceed 48" x 48" horizontally or vertically.

3D WORK

Front & Back view of 3D entries for each submission ceramics & sculpture must provide their own pedestal or display stand and attach their work in a secure manner.

LIABILITY

TVAA and the Mesquite Arts Center will not be responsible for the loss of or damage to any work of art. Entry into this exhibition constitutes the artist's agreement to these terms and conditions. TVAA reserves the right to not show any works not deemed appropriate for public viewing.
