Strike: Sunday, June 3rd, 4 pm to 5 pm

Guidelines

- Work must have been created within the last 5 years.
- All media eligible. Sculpture must have its own base and stand.
- Maximum size of 2D work is 48" x 48", framed and wired for hanging. Gallery-wrapped canvas is acceptable without framing if sides are appropriately finished.
- Weight should not exceed 15 pounds.
- Special care should be taken when wiring heavy work, particularly if framed under glass. Using Plexiglas and/or double wiring is recommended.
- Work that is still wet or inadequately wired when delivered will not be hung.

Limitations will be enforced. All participants are required to sit with the show for one ½ day, either 10am - 1pm or 1pm -4pm, so know your schedule.

Entry Fee

Each member may enter one work for \$15. Existing members may pay dues during registration on May 12th, and we welcome new members at this time. TVAA does not take a commission on any work that is sold. Medical City receives 15% of final sales.

Liability

All reasonable care shall be exercised with entries. Neither TVAA nor Medical City, however, will be responsible for loss or damage. Participation constitutes agreement. TVAA and Medical City reserve the right to refuse any work deemed unacceptable.

Juror

Prizes will be awarded by Mary Tomas. MARY TOMÁS GALLERY is a contemporary fine arts gallery owned and operated by Mary and Alberto Tomás. The current space opened in 2009 after Mary served as gallery director for al-so gallery since 2001. With over 40 years' experience in the art business both Mary and Alberto share a wealth of knowledge.
